

COGHILL STRING INSTRUMENTS SALES BY CONSIGNMENT AGREEMENT

This Sales by Consignment Agreement ("Agreement") is made and entered into as of [Date]_____, between Douglas Coghill (hereinafter referred to as the "Agent"), and _____ (hereinafter referred to as the "Owner").

1. Appointment of Agent: The Owner hereby appoints the Agent as an exclusive agent for the sale of the following instrument or bow ("Item").

2. Consignment Terms: The Owner agrees to consign the aforementioned item to the Agent for the purpose of sale under the following terms and conditions:

- The Agent agrees to list the item for sale on behalf of the Owner.
- The Agent shall charge a commission fee of twenty percent (20%) of the final sale price of the item.
- The Agent shall charge a listing fee of one hundred and fifty dollars (\$150.00), payable upfront by the Owner.
- The Owner will need to pay for any repairs to the item before being put up for sale.

3. Pricing and Sale:

- The Agent shall determine the initial sale price of the item, in consultation with the Owner.
- The Owner agrees to accept the final sale price as negotiated by the Agent, subject to the Owner's approval.
- The Agent shall use best efforts to secure a reasonable and fair price for the item.

4. Duration of Agreement: This Agreement shall commence on the date of signing and shall remain in full effect until the item is sold, unless terminated earlier by mutual agreement of both parties.

5. Title and Ownership:

- The title and ownership of the item shall remain with the Owner until such time as a sale is completed and full payment is received by the Agent.
- In the event of the sale of the item, ownership shall transfer to the purchaser upon receipt of full payment, and the Agent shall promptly remit the proceeds of the sale, less the agreed-upon commission fee, to the Owner.

6. Termination: Either party may terminate this Agreement upon written notice to the other party prior to the sale of the item.

7. Insurance:

The Agent will not insure the item being sold on commission. It is up to the Owner to arrange their own insurance if they should choose. The Owner cannot hold the Agent responsible for any loss or damage to the item under any circumstances.

8. Trials: The Agent may allow a potential buyer to borrow the item for a trial period of 7 calendar days. The Owner agrees not to hold the Agent responsible for any loss or damage to the item which may occur whilst in the possession of a potential buyer.

9. The Owner is responsible for any repairs or maintenance costs to the instrument(s).
